TOWN OFFICIALS

HIGHWAY SUPERINTENDENT

- Written Budget Highway report on file in the Office of the Town Clerk.
- Coates Road will be closed Monday-Wednesday to change out a cross-over pipe. Guardrails will be installed in the gulley area. CHIPS monies will be used to fund this project.
- We are working with Yates County Soil & Water to hydro-seed Scott Road.
- Highway Superintendent Hurd is going to Milton CAT to check on damages to the excavator rolled on January 4th. Repairs are currently estimated at \$147,000. The insurance company did not total the excavator. He will confirm that we can reopen this claim should further damages be found.

COUNCIL

- Councilor Lent emailed notes from the April 2nd Water/Sewer staff meeting.
- Councilors Purdy and Bird will conduct an initial screening of grant writing consultants.
- Councilor Purdy explained pending State legislation requiring local elections to be held in even years; except for the Sheriff, DA and County Clerk. She will continue to work on this, noting timeliness is important to allow the Board of Elections time to prepare ballots.
- Councilor Bird stated Code Officer McKinley is doing a phenomenal job. He issued a citation at 8835 East Bluff that required filing a Use Variance application. Review resulted in the Zoning Board directing living quarters to be removed from their boat house.
- Councilor Jones stated Clean Up Day will be Saturday, June 15th, 8:30-12:30. This will be posted on the website and ads placed in the Chronicle Express.

SUPERVISOR

We continue to work with Attorney Buck to draft contracts for the Wholesale Water customers with the Village of Penn Yan. Jerusalem and Milo also need to renew our sewer contracts with the Village. Extending the contract to 40-years will result in a projected cost

reduction from 20% to 7% to fund sewer projects.

PRPOSED LOCAL LAW B-2024 CHAPTER 147, VESSELS, MOORING OF AMENDMENT Attorney Graff is drafting a local law amending Chapter 147.

WATER REHAB PHASE 3 CAPITAL PROJECT

We received the affidavit of publication for the March 28, 2024 Notice of Estoppel for the Water Rehab Phase 3 capital project.

Plans for the Phase 3 capital project are under review by the New York State Department of Health.

466 RITCHEY BLVD. ENCROACHMENT LICENSE AGREEMENT

The garage at 466 Ritchey Blvd. encroaches on the town highway. The owner submitted a written request to the Town Board for authorization to maintain such wall during the time such wall is in existence. Notice has been given to Highway Superintendent Hurd for his recommendation on the request.
