OTHER BUSINESS:

There was a brief discussion regarding the purchase of "The Short Course" booklet to be used by individuals on the Zoning & Planning Boards for self-study to get the State required credits needed as board members.

REORGANIZATION:

A second motion was made by E. Seus and seconded by J.Bird to have Jim Crevelling be the Vice-Chairman for 2010. Discussion followed. The Zoning Secretary called for a show of right hands for those in favor of Jim Bird as the Vice-Chairman with all board members and alternates present voting. There were three votes for Jim Bird. The Secretary called for a show of left hands for those in favor of Jim Crevelling as Vice-Chairman. There were three votes for Jim Crevelling. Having a tie situation, Jim Bird stated that he wished to decline taking the position for Vice-Chairman.

Board Members were in agreement that Jim Crevelling will be the Vice-Chairman for 2010.

There being no further business, a motion was made by E.Seus and seconded by J.Crevelling to adjourn the meeting. Motion carried (6-yes, 0-no). Meeting adjourned at 6:20 pm.
