THE PLANNING BOARD'S PUBLIC PRESENTATIONS

- A. OLD BUSINESS
 - a. None
- **B. NEW BUSINESS**
 - a. David and Lori Slomovic Property located at 9291 East Bluff Dr, Penn Yan, NY 14527. Tax Parcel 110.33-1-5
 - i. Steep slopes
 - ii. SEQR
 - b. SEQR
 - i. David Slomovic presented plans dated May 4, 2011 by Michael R. Johnson, P.E. to build a retaining wall along the lake. This wall will need to be built before a new residence to be built in the future.
 - 1. A memo was received by Elaine Nesbit from Rick Ayres dated May 25, 2011.
 - a. Rick commented that the wall end sections are getting very close to mean high lake level (715.3) Rick suggested mean high should be marked before construction starts

- b. Rick also mentioned that a silt fence should be installed to NYS standards above mean high to stop any sediment escape.
- 2. Bob Evans stated that the property should be marked so that Planning Board members could find it.
- 3. Mr. Slomovic presented pictures of the property to show how the land lays out.
- 4. Mr. Slomovic met with John Phillips and Rick Ayers to discuss the project and to determine exactly what accommodations need to be made to enhance local approval and to move the project along.
- 5. The lot to the east had been cleared by Pete Townsend who has extensive expertise in the area. He will prepare the wall before foundation goes in.
- 6. The south side drops off more rapidly and in the plan it is Mr. Slomovic's intention is to have the wall string across 722' above sea level.
- 7. On the north side the wall will come down to 716 feet, the wall will be buried 6ft.
- 8. A silt fence will be built NYS standards between the mean high water lines.
- 9. DEC stated that the wall should stay north of the main water line.
- 10. A rail system will be installed to bring a boat in.
- 11. Mr. Slomovic has watched the slope modify.
- 12. Roger Langdan is the representative from Barden homes.
- 13. Doug Chapin, rep from Ready Rock said he would welcome the opportunity to oversee and work with Pete Townsend in the building of the wall.
- 14. It was noted that the plans that were submitted had been modified.
- 15. It was asked by the Planning Board that new plans be submitted with the changes included along with the construction sequence.
- 16. Bob will meet with Elaine to be sure that what we need is received.

A motion was made by Bob Evans to not approve the SEQR and Steep Slopes Application based on the fact that the plans had been modified. The Planning Board will need to receive new plans before the next meeting. This SEQR will be tabled until the next Planning Board meeting on July 7th, 2011.
