With proof of notice having been duly published and posted, Supervisor Jones opened the Public Hearing on proposed Local Law D-2008 providing for Low Impact Wholesale Business in the Town of Jerusalem at 7:05 P.M. Supervisor Jones presented a summary of conduct for the public hearing and read the local law.

Max Parson supports the local law stating it is long overdue and the Town needs to move ahead.

Bob Evans stated the Planning Board has some concerns with the local law as proposed, but are not opposed to it tonight. The Planning Board's concerns will be addressed at a later time.

Lincoln Charles requested verification of his understanding of the local law as proposed. He asked if existing buildings that do not comply with the set backs would be grandfathered in.

In response to a question from Bob Johnson regarding the definition of "non-retail" in Section 2. that conflicts with Section 4. 6. Retail space, if any, is not to exceed 10% of total floor area of the building., Section 2. was amended to state "limited retail" instead of "non-retail".

Town Engineer Ackart stated the word "short" needed to be deleted from Section. \_\_ Application regarding the environmental assessment form that needs to accompany an application because it could require either a long or short form.

The public hearing was left open.

Lincoln Charles spoke to his specific needs that would allow him to relocate his foundry operation that produces high-end high-value commodities to the Town of Jerusalem.

Whereas, Highway Superintendent has received four quotes for a wood burning furnace to be used for heating of the Highway Department buildings. Gowiski Sales 7 Service, Arkport, New York meets the necessary requirements at the lowest price.

Diversified Energy Systems, Heatmor Model #400 DCSS \$9315.00

Now, therefore, be it resolved that the Town Highway Superintendent is hereby authorized to purchase the following: one (1) Wood Master Outdoor Wood Burning Furnace, Model #5500 from Gowiski Sales & Service, Arkport, NY in the amount of \$7250.00, to be used for heating purposes at the Highway Department Garage.

The proceeds for this purchase shall be taken from General Garage Account #5132.4.

Councilperson Simmons and Supervisor Jones met with Bob Multer to discuss possible shared services whereby the Highway Department would plow County roads like Middlesex and the Town of Milo do. Highway Superintendent Payne has considered this and is of the opinion that with 112 miles of road we currently plow, we do not have the time to cover any more miles of road. Also, there is not any stretch of County road that we already travel that we could plow on their behalf.

#### TOWN ENGINEER

Town Engineer Ackart reported the Town of Pulteney has approximately 160 connections and they estimate 200 connections by year end.

A meeting was called by the Hornell State Health Department with the Geneva State Health Department, Pulteney and Jerusalem to discuss re-chlorination, THM's and tank fill procedures. We anticipate significant expenses related to needed revisions at the Village of Penn Yan Water Treatment Plant. The Village of Penn Yan is in receipt of their draft 2006-2007 audited financial statement. Copies of the statement will be mailed to their wholesale water customers within seven days after being approved. Our water usage can then be reconciled to the audited financial statement.

Work on the 2009 water and sewer budgets is underway.

#### COUNCIL

Councilperson Stewart noted both the concert at the War Memorial and the program at the Branchport Library on August  $12^{\rm th}$  were well attended. Because we do not have a VFW or American Legion, he suggested the Town look to do more community events. Stewart and Bob Evans will coordinate an event such as an ice cream social or B-B-Q.

The Town has received numerous complaints regarding property maintenance. The Grievance Board informed the Town Board grievances were filed because of property maintenance issues. The Code Enforcement Officer is issuing violation notices to address these matters.

Supervisor Jones read the following Council Report from Loretta Hopkins:

We (the Town Board) have received a letter from the Grievance Board speaking to us about their concerns that several grievances came because of property maintenance in the hamlet of Branchport. Although some relief was granted to property owners, they believe the problem may be much broader.

Coinciding with the apparent problem locally, CNN and ABC recently presented commentaries showing property maintenance as a national problem devaluing neighborhoods by 20% and much more depending on the scope.

Our Code Enforcement Officer has cited four of the offenders at this time and will soon be citing more.

I respectfully request that the Resolution for the Land Reserve Fund and the hour adjustment for the KPSW Water Clerk be tabled until the September meeting when I can comment on these issues.

Also, I have a response to Councilman Folts' complaints about day time meetings and would like to address them at our next public meeting.

Supervisor Jones also received a letter from Debbie Koop requesting the Town Board refrain from voting on the use of Twix Pines settlement monies to establish the land reserve fund.

#### SUPERVISOR

Supervisor Jones stated upon the sale of 687 West Bluff Drive, it was discovered a shed is encroaching on the highway right-of-way. Supervisor Jones informed Town Attorney Bailey that because the previous owner did not obtain a building permit to place the shed on the property, their options are:

Remove the building from the property

Apply for a permit and meet the proper setbacks

Apply for a permit with same setbacks, the Code Enforcement

Officer will then deny, and they can apply for a variance.

Supervisor Jones has not heard any further on this matter.

#### ZONING REVIEW/TOWNHOUSE SUBCOMMITTEE

Planning Board Chair Evans stated the Subcommittee recommended to the Planning Board at their August meeting that townhouses be allowed in the Branchport Service Park. Regulations for townhouses have not yet been completed for the Town. Supervisor Jones advised George Sproule of the Planning Board's recommendation.

#### SUBDIVISION SUBCOMMITTEE

Subdivision Subcommittee Chair Close stated they met last night to review the draft regulations and the alternative approach recommended. They will meet next week to continue discussions.

#### WIND FARM SUBCOMMITTEE

Councilperson Simmons stated the Wind Farm Subcommittee will be meeting September  $3^{\rm rd}$  to start looking at rules and regulations to allow wind farms within the Town. Jim Barre is now chairing this subcommittee.

ZONING ASSESSMENT PLANNING (ZAP) OPERATIONS REVIEW SUBCOMMTITEE With budget sessions currently upon us, Councilpersons Folts, Simmons and Stewart will be looking at the ZAP Operations Review Subcommittee report in October with a January start date for implementation of the recommendations.

#### ROUTE 54A ADDRESSING PROPOSAL SUBCOMMITEE

Alice Hunt provided an update on the July 31<sup>st</sup> Subcommittee meeting with Yates County Sheriff Ron Spike, Code Enforcement Officer John Phillips, Councilperson Stewart and Supervisor Jones. While Sheriff Spike was receptive to the Town's problems, the Emergency Management Services (EMS) works well on its own and has components available to only EMS. EMS has mechanisms in place to deal with the duplicate addresses that currently exist.

Bob Johnson also spoke to the July 31<sup>st</sup> meeting and presented the Board with an outline of the address proposal support as follows:

Sheriff Spike has promised full cooperation and assistance as the Town updates its property-address listing. This includes sharing mapping software and the map book used by 911 and the road patrol officers to locate properties.

Sheriff Spike has pledged \$2,000 towards a fund to pay for the numbers needed for a door-to-door "Get-Those-Numbers-Posted Campaign." Such a campaign would assure numbers being posted throughout the Town of Jerusalem.

Sheriff Spike has stated he understands the need for local road names even though 911 doesn't need them, and that 911 can easily work with local road names. He has also stated that he favors using the modified Stark numbering system (1000-numbers per mile) for numbering the lake roads.

The US Postal Service has recently provided us with two alternative form letters that can be used for notifying residents about their change of address. As previously stated, the USPS will pickup the postage for all letters containing their form letter with the US Postal Service insignia on it. This is an estimated \$1000 cost to the USPS.

Petitions presented with, and attached to, the proposal demonstrate public support from each of the roads/streets directly involved. The sampling indicated over 90% support from the residents living along each of these roads.

Also attached to the proposal presented on June 18, 2008 were

several Declarations of Support from individuals, mostly from the Penn Yan and Jerusalem business community - people whose business relies on the addressing system for accurate and efficient delivery of their goods and correspondences. The July 30, 2008 issue of the <u>Chronicle Express</u> had an extensive article about the proposal. The committee has received several positive responses; "When and what is going to happen?" "How soon can we expect this to take effect?" We have heard no adverse reactions.

Volunteers are available and willing to do much of the work: renumbering, address correcting, preparing and information flyer, preparing notifications, stuffing envelopes, answering phones and whatever other assistance is possible. This will minimize the extra work required of town personnel resulting from the passage of the Addressing Proposal.

All the departments with the Jerusalem government have gone on record as being in support of the merits and the improvements that the Address Proposal will bring about. Mr. Johnson presented the Town Board with a letter of support signed by staff at the Town Hall.

Supervisor Jones and Councilperson Stewart will meet with Mrs. Hunt and Mr. Johnson on August 27 to continue review and discussion of the addressing proposal.

#### MEETING TIMES

A lengthy discussion ensued regarding Councilperson Folts' comments regarding daytime meetings given two recent special Town Board meetings and the upcoming budget meeting schedule. Supervisor Jones stated that the budget workshops and hearing have not been scheduled to date, but they will be scheduled for the convenience of the majority and employees' schedules will be taken into consideration if they need to attend.

# REQUEST FOR SUPPORT - AG & MARKETS FARMLAND PROTECTION GRANT PROGRAM

Sue Gillette, 2658 Sand Hill Road addressed the Board regarding their application to the New York State Department of Ag & Markets Farmland Protection Implementation Grants Program that

Peter Landre, Cornell Cooperative Extension Executive Director supervises. The State has a competitive grants program for farmland protection that provides up to 75% cost share for the purchase of development rights. The landowner or other entity pays the other 25%. The Gillette and Mike Folts' farms were selected through a competitive process to be applicants for this year's State program. Support from the Town is not required, but was requested of the Town since the Town's Comprehensive Plan clearly identifies protection of farmland as a major goal. If funded, it will result in the protection of 247 acres on the Gillette farm and 52.5 acres on the Folts farm.

Whereas the Finger Lakes Land Trust has agreed to hold, monitor and enforce the conservation easement, should the projects be funded; and

Whereas Folts and Gillette have agreed to pay 25% of the cost share of the project; and

Whereas the Town of Jerusalem values the contributions and protection of agriculture in the Town and recognizes the important opportunity the New York State Farmland Protection

Implementation Program provides for farmers across the state; now, therefore, be it

Resolved, the Town of Jerusalem supports the application of the Folts and Gillette farms for the New York State Farmland Protection Implementation Program.

Should that initial fee be insufficient to cover the services rendered, the applicant will be notified and all additional fees incurred from that point forward will be billed to the applicant. Professional Service Fees must be paid in full prior to the issuance of the Steep Slopes Permit.

Should the cost of Professional Service for any Steep Slopes Application be less than the \$500.00 mandatory fee, the Town will return the unused portion to the applicant upon the issuance or withdrawal of said Application; and, be it further

Resolved that this Steep Slope Fee become effective immediately and that said fees be added to the Town Fee Master List in the Town Clerk's Office.
