OTHER BUSINESS:

Zoning Secretary noted for the board that there will be two new applications along with the tabled application for review at the April Zoning Board meeting.

M. Steppe gave a report on the Rte 54A Sub-Committee that has been working on the rezoning of Rte 54A. M. Steppe stated that at their last meeting, a decision was made to "pause" for a time, on the work that they as a sub-committee have been doing. The sub-committee that has been working on the restoration of the hamlet of Branchport, has received a "grant" to help in this effort. A consultant has been hired to help with this project. It was noted that many of the issues for both the sub-committee working on the Rte 54A re-zoning and the sub-committee working on the restoration of the hamlet of Branchport, are the same. It is hoped that maybe these two groups, having the same goals, can work cohesively on these projects rather than individually.

A public meeting regarding this effort is tentatively being scheduled for early June.

It was also noted that the Branchport School has been sold to the Finger Lakes Historical and Cultural Museum.

There being no other business, a motion was made by J.Crevelling and seconded by M.Steppe to adjourn the meeting. The motion was carried unanimously (5-yes, 0-no).
