WHEREAS, the Keuka Park Consolidated Water District (the District) comprises approximately 28 miles of water main serving approximately 2900 residential customers and 30 commercial and institutional customers, including Keuka College, together with three reservoirs, five remotely controlled mainline valves, rechlorination and pumping facilities, and transmission of the water supply for the Town of Pulteney from the Penn Yan water treatment facility to the Pulteney system, all of which require continuous coordination due to changes in water quality and demand for water from time to time, which is not within the control of the District; and

WHEREAS, the District is comprised of the original Keuka Park Water District and its three extensions, which were created and constructed at different times over more than forty years; and

WHEREAS, the District presently needs new control and telemetry equipment to replace worn out and outmoded control equipment in Keuka Park that has been in use for upwards of 15 years, and

WHEREAS, as a result of the irregular growth in the infrastructure of the District the equipment used to control the flow of water from the Penn Yan water treatment plant to the reservoirs and from the reservoirs to the customers has been acquired at different times and is now outmoded and less efficient than a new system of control equipment would be if it were properly designed and integrated for the specific needs of this district as a whole; and

WHEREAS, the acquisition, integration, and installation of this equipment requires the customization of computer software and programs in combination with the careful choice of new control devices and radio equipment, all of which must be compatible with each other and with the existing facilities so as to allow smooth

and efficient remote control the various reservoirs, pumps, piping, and other devices now in place in the District, and

WHEREAS, the New York State Comptroller has opined (Opinion 85-35) that the public bidding requirement of General Municipal Law, Section 103, does not apply to situations where the items and services to be purchased are of a primarily technological nature that require specialized skill in the design, adaptation and customization of new equipment and computer software in order to integrate the same with existing infrastructure; and

WHEREAS, the Town Engineer has surveyed the firms available in this area that could design, create, and install the system described and has determined, after considering several such firms, that AquaLogics Systems, Inc. of Syracuse, New York possesses the necessary experience and technical expertise to design, create, and install a suitable system of control and telemetry equipment for the District and is otherwise reliable and diligent; and

WHEREAS, AquaLogics Systems, Inc. of Syracuse, New York has examined the existing infrastructure of the District and submitted a proposal (a copy of which is attached hereto and made a part hereof) for the appropriate new equipment together with the customization and installation of it at a price of Seventy-seven thousand six hundred dollars (\$77,600.00); and

WHEREAS, the Town Engineer has therefore recommended the purchase and installation of the equipment described; and

SUPERVISION: Work is performed under the general direction of the Town Supervisor and Town Board.

## WORK SCHEDULE:

The Sole Appointed Assessor will work an average of 24 hours per week on Monday, Tuesday and Thursday of each week from 8 AM to 4 PM, his regular work days. The Sole Appointed Assessor will be present in the office during regular work days, unless work must be

done outside the office or in an emergency. The Sole Appointed Assessor will not be required to work any regular work days when the Town is officially closed for business.

At a minimum, Sole Appointed Assessor shall have posted office hours of at least four hours per day on Tuesday and Thursday of each week. During office hours the Sole Appointed Assessor will be available to meet with members of the public, respond to telephone calls and e-mails, and perform document and related office work. Additional office hours may be scheduled by the Assessor or Town Supervisor, as needed, to meet with the public or town personnel.

The Sole Appointed Assessor shall perform his remaining duties during non-office hours. When he will be working outside the office during a regular work day, he will notify the Supervisor in advance and advise his secretary (or someone else in the office if secretary not available) of his schedule and where or how he can be reached.

COMPENSATION AND BENEFITS:

The Sole Appointed Assessor will be compensated on a salary basis, as determined annually by the Town Board. Any benefits shall also be determined annually by the Town Board, and shall be documented in writing.

AGREEMENT: The above terms are agreed to. Vernon Brand, Daryl H. Jones, Sole Appointed Assessor Supervisor

SOLE APPOINTED ASSESSOR TYPICAL WORK ACTIVITIES: -Annually values and revalues each parcel of real property; -Utilizes and maintains current tax maps and appraisal cards; -May seek county advisory services in determining values of certain parcels; -Attends all hearings of the Board of Assessment Review; -Makes changes in assessments in accordance with law as directed by the Board of Assessment Review; -Appoints and trains an acting Assessor to perform as needed; -Attends the public examination of the tentative assessment roll at times prescribed by law; -Receives complaints filed and transmits them to the Board of Assessment Review; -Prepares reports of assessment activities as required by the appointing authority of the State Board of Equalization and
