New Business:

Pat Killen attended the last meeting of the Keuka Park Residents Association and was made aware of several issues. The County Highway Department, the State Department of Transportation and the Sheriff's Department have all been asked by the Town to look into parking and speed limits in Keuka Park. Although the current posted speed limit is 30mph, it was thought to be 35mph. The Department of Transportation will determine if it should be lower and if there should be more speed limit signs. All 3 of the agencies should be working together to address this situation.

From the County's point of view there have been a lot of issues that have been going to the

Sheriff's Department such as traffic, speeding and parking not only in Jerusalem but other towns within the county. The Sheriff's Department is becoming aware of these and other issues and is trying to address them. Chairman Cutler asked that the Sheriff be notified if additional problems need to be addressed.

Wheeler commented that some of the issues have been going on for years.
