WHEREAS, the Town of Jerusalem Board has now received and reviewed Parts 1, 2, and 3 of the EAF for the proposed action and all supporting documentation appended thereto; and

WHEREAS, the Town of Jerusalem has thoroughly analyzed the identified areas of environmental concern to determine whether the proposed Action may have a significant effect upon the environment; and

WHEREAS, the Town of Jerusalem has reviewed the criteria for determining significance specified in 6NYCRR Part 617.7 and has therefore recommended that a Notice of Determination of No Significant Impact ("DONSI") be adopted; now therefore, be it



### YATES COUNTY REPORT

- Legislator Killen presented the County report.
- Legislator Killen will take Supervisor Sisson's requests back to the Legislature to add 1% to the occupancy tax that would be collected and given back to the Towns and to distribute the County road millings proportionately with the townships' miles of roads.
- Legislator Cutler distributed the latest draft of the Yates County Farmland Protection Plan to the Planning and Town Boards. The County anticipates its adoption by November 2023.
- A healthcare consortium including the County and Towns is being reviewed as a cost saving measure under the State mandated County Shared Services Initiative (CSSI) program.
