NOTICE TO BIDDERS

Sealed Bids for the Phase 3 Water Main Improvements Project will be received by the Town of Jerusalem at the Town Office, 3816 Italy Hill Road, Branchport, NY 14418 until 10:00 A.M. prevailing local time on July 30, 2024. The Bids received will be publicly opened and read aloud at that time.

Contract: Phase 3 Water Main Improvements

The contract generally consists of the installation of approximately 6,500 ft of HDPE watermain using primarily directionally drilled methods, 40 water services, and 10 new fire hydrants in the Keuka Park Water District. The work includes all associated backfill and surface restoration required as a part of the work along with other work specified and indicated on the Construction Drawings.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis, with additive alternate bid items as indicated in the Bid Form.

Interested parties are required to register on the website for the ability to view and/or acquire the Bidding Documents for the Project. It is the responsibility of any person or organization interested in a hard copy of the Bidding Documents to pay all costs associated with printing. A pre-bid conference is not being held. Bidder questions can be submitted through the website.

Bids shall be sealed in an opaque envelope and clearly marked "Town of Jerusalem – Phase 3 Water Main Improvements Project.". The envelope must also bear the name and address of the bidder.

Each bid shall be accompanied by a certified check or bid bond in the amount of five percent (5%) of the maximum amount of the bid, as a guarantee that the bidder will execute the contract and furnish the necessary bonds if the contract is awarded to him/her.

The Contractor shall ensure that employees and applicants for employment are not discriminated against because of race, age, color, religion, sex, national origin, or handicap status.

The Supplementary Conditions set forth requirements for the payment by the Contractor and its Subcontractors of minimum wage rates for all classes of laborers and mechanics as set forth by the General Prevailing Minimum Wage Rates as determined by the New York Department of Labor, Article 8 Public Work, as applicable to the Work.

The Town of Jerusalem reserves the right to waive any irregularities, to reject any and all bids, and to award the contract to the lowest responsible bidder. No bidder may withdraw his or her bid within sixty (60) days after the actual opening thereof. Bid security shall be furnished in accordance with the Instructions to Bidders.
